BROEGE CLUTCH IN THE TENTH TO TAKE TOFC

RJ BROEGE from West Hartford, CT added the Tournament of Champions title to his resume by beating NEBA's most winning bowler with a mandatory double to end the championship match. This was RJ's fourth career title and second in 2008. His first win was in September 2003 at Bradley Bowl, his second at the 2007 trios and his last at Bowl-O-Rama in May. At Norwich, the 28 year-old threw games of 268, 238, 237, 222 and 202 in qualifying. His 1167 was 12th out of the record breaking 62 bowler field. In round one, he went up against Craig Asselin who was coming off his runner-up finish earlier in the month. He moved onto the second round after besting Craig's two game total of 407 with 452. RJ then advanced through round two in a tenth frame thriller against Steve Fiume. Steve left a split in the tenth to give RJ a single pin 440-439 win. The semi-final round was another one pin victory over tournament high-qualifier Chris Sole 412-411. In the championship match, RJ was down after four frames then strung strikes while his opponent was unable to throw a double. He took game one 226-185 to go into game two with a huge 41 pin lead. That seemed like it would be hard to make-up but within three frames, RJ was behind. His opponent kept striking through the sixth then both bowlers threw splits late in the game to keep the match exciting and close. Since RJ struck in the ninth, he gave himself the opportunity to strike out to win after Michael left an 8-pin on a high hit. The smooth lefty tossed two strikes plus nine on the fill to win by four sticks. His clutch shots when he needed it gave RJ \$1,400 plus a paid entry to defend his title next year and kept him in the Bowler of the Year race with just one tournament to go. He jumped from fourth to second in points only 24 behind 6-time Bowler of the Year Bill Webb.

MICHAEL LICHSTEIN from Broad Brook, CT shot games of 246, 247, 225, 245 and 243 for 1206 to qualify 10th then threw some big games in match play en route to the championship match. He started off by defeating 2006 ToFC winner Frank Calca 547-467 then 458-443 against new champ Todd Lathrop and used a big set to get by Westfield's Chris Viale 547-418 in the semis. Michael, who recently turned 40, started the 2-game match against RJ with his only sub-200 game of the day. He came back strong with the front six in game two but fell four pins short in the long format. This is similar to his last runner-up finish in September in which he came within a shot of winning but, much like the Yankees, he failed to win his 27th championship. The left-hander's last win was in September 2007 at the now closed AMF Hamden Lanes. He won \$900 for his second place and moved up to sixth in points.

There were 62 entries at the 2008 Tournament of Champions. This was the largest field since its inception in 1993. The cut to match play was 1158 (16th place). **Chris Sole** was the tournament high qualifier with 1263 with games of 247, 267, 238, 279 and 232. **Dan White** won the \$50 high game out of the money prize with 299. The field average for qualifying was 220.9 and jumped to 229.6 in match play. **Honor Scores: 11 in-a-row by Todd Lathrop (299) and Dan White (299)**

JOHN RUSIN RUNS OVER NON-CHAMPS FOR FIRST WIN

JOHN RUSIN from Fall River, MA won his first title with a convincing 255-194 final match victory over Tony Bennett at Norwich Bowling & Entertainment Center. John started his championship day with 275, 226, 245, 241 and 207 for 8th on the morning squad with 1194. After a one round bye, the righty defeated Alvin Horne 206-183, Chris Sevic 228-196, Vin Marulli 204-179 and Brian Frank 218-169. In the championship match, he impressive shots; hitting the pocket every shot leaving only a 4-9 and a ringing 10 out of his 11 shots. This easily won him his first title, the honor of wearing a white champion's shirt, \$1,650 and a paid entry into the Tournament of Champions the next day. John, who hit the big 4-0 in September, had one previous championship match appearance in April 2007 at Laurel Lanes.

TONY BENNETT from Worcester, MA used games of 221, 207, 257, 243 and 235 for 1163 to grab the last guaranteed spot off the first qualifying squad. In the first round, he threw a 201 to advance with Jim Bosse, 267, against Dan McCormick's 184. He followed that up with solid games for victories over John Younger 255-184, Randy Hagemoser 248-241, John Williston 235-229 and Terry Perssico 206-183 for a spot in his first championship match. Tony was unable to put together strikes to keep pace with John. Prior to this runner-up finish, the 23 year-old had a few top 16 finishes out of the 13 tournaments he has bowled since he joined in late 2007.

There were 180 entries in Norwich for the second Non-Champions tournament in 2008. The newly renovated 32 lane center drew better than expected. After receiving over 90 reservations for the first squad, six bowlers were put on a pair for the first time. Forty bowlers advanced into match play with the at-large cut at 1124. Squad cuts were 1163 at 10AM (squad leader **Larry King** with 1279) and 1097 at 1:30PM. (squad leader **Vin Marulli** with 1231). The score needed for a one round bye was 1175 with 290 high. **Don Fournier** won the extra \$50 senior prize with 1106. **Larry King** was the tournament high qualifier with 1279 on the Sunday morning squad with games of 268, 276, 289, 222 and 224. **Joey Nereu** won the \$50 high game out of the money prize with 290. The one Ebonite raffle for the weekend was won by **Jim Sansone** for a reservation in the non-champions. The field averaged 207.7 in qualifying and 208.0 for matches.

 - c. In doubles events, allow bowlers to switch partners.
 - d. Increase the minimum to cash ratio from 1 in 5 -to- 1 in 5.5 (chart of entries to be presented at meeting)
 - e. Increase optional side pools from \$20 -to- \$40
 - f. Raise entry fee to \$85
 - g. Eliminate Paid Practice on Tournament Lanes – This proposal would eliminate paid practice and increase lineage rate which currently is between \$1.50 and \$2.00 to \$3.00 a game for all centers thus increasing lineage by a minimum of \$6.
 - h. Increase the amount of practice during the first round of match play 5 minutes to 10.
 - i. Strip & oil the lanes before match play -or- Strip & oil the lanes before match play when time allows.
